The total TOT collections through the first quarter of the fiscal year 2024/25 are \$2,162,170.10. This equates to 34.32% of the budgeted revenue of \$6,300,000.00 for the 2024/25 fiscal year.

The Treasurer-Tax Collector's Office is responsible for the administration and collection of transient occupancy tax (TOT) for establishments located in the unincorporated areas of the County.
